All appeals and grievances require a fee of \$250, to be paid up front by the individual or organization filing the appeal. If the appeal is upheld in your favor, \$150 will be sent back to the individual or organization filing the appeal. The remaining \$100 is retained by OSA as an administrative fee. All fees collected for grievances will be retained by OSA as administrative fees.
